

The Care Act 2014

The Care and Support Statutory Guidance 2014 Chapter 14

"Safeguarding means protecting an adults rights to live in safety, free from abuse and neglect...whilst at the same time making sure adults' wellbeing is promoted and where appropriate having regard for their views, wishes, feelings and beliefs.

Section 42 Adult Safeguarding Duty

There is a **statutory** duty to safeguard some adults in some circumstances:

- a. Has need for care and support whether or not the LA is meeting those needs
- b. Is experiencing or at risk of experiencing abuse or neglect
- c. As a result of those needs is unable to protect his or herself from abuse or the risk of it.

There is also a **non-statutory** offer of support for all adults where it may be applicable

How do wellbeing principles apply to dance teachers

| Personal dignity | Being able to 'dress up', having a reason to go out |
|--|--|
| Physical / Mental Health and Emotional wellbeing | Mental stimulation learning new routines Physical exercise Artistic Expression |
| Protection from abuse and neglect | Increase safe relationships (modelling, safe space for disclosure) |
| Control over their day to day lives | Choice over classes, clothes, competitions etc |
| Participation | To be part of a group |
| Social and economic wellbeing | Training vocational students (to provide economic options) |
| Domestic, family & personal | Socialisation, making friends, shared experiences |
| Suitable living accommodation | As an employer, you afford financial ability to afford accommodation |
| Contribution to society | Older pupils helping with junior classes |

How does this apply to dance teachers?

- Adults are not obligated to tell teachers about their personal circumstances
- Unseen disabilities
- Trauma informed practice
- Not making assumptions
- The relationship and emotional interaction between teacher and adult


10 types of abuse for adults

Referral Pathways

A capacitated adult who is speaking to you about their concerns

Signpost to and/or support contacting : GP / Social Care / Domestic Abuse services / Substance Misuse services etc

An adult who does not know what help they need.

You do not know what advice to offer

Seek advice from:
DSL internally or ISTD DSL / Local Authority

An adult who is at immediate risk of harm and unable to resolve the issue themselves

- Ambulance
- Social Care appropriate)

If someone is incapacitated you do not need to rely on consent
