## Cover for Public Liability will extend to the limit shown on their policy schedule to a maximum indemnity of £5,000,000.

#### There are requirements that the member must meet for their cover to be extended. These are:

1. Streamed classes are subject to the same safeguarding rules in place for all events and classes.

2. Members must ensure that an adequate health and safety warning is issued to all participants either verbally at the start of the class, or preferably by email to those joining. As an example we would expect a member to advise participants to ensure that they:

(i) have enough room to participate in the activity without there being any obvious risk of injury to themselves, to others, or risk of any damage to surrounding property

(ii) ensure that the flooring in the room is safe for the activity to be undertaken

(ii) ensure that where appropriate and especially in respect of activities for children, participants have a suitable parent/guardian present, or as a minimum, have their consent to participate at home.
